  - 8.1 Proposed Minor in Equity and Education Studies (AS-1127-20/CEPC/URC)— SECOND READING
    - Second reading moved and seconded. Corinne Martinez from Liberal Studies was present to answer questions.
    - Passed the second reading. Voting Results: Yes=44, No=1.
  - 8.2 Proposed Revision of PS 17-18, Employment of Graduate Students as Student Assistants, Instructional Student Assistants, Graduate Assistants, and Teaching Associates (AS-1100-19/FPPC)—SECOND READING
    - (Resuming at) Line 67 amended by T. Armstrong, moved and seconded. Add *"ISA positions should be designed specifically to help the graduate student improve their command of pedagogical techniques. GA positions should be designed specifically to help students gain command of key skills in their discipline and/or career readiness competencies."* A friendly amendment (FA) proposed by N. Schurer to change *"should"* to *"may."* FA was accepted by TA. Voting Results: Yes=24, No=25. Amendment *Fails*.
    - Lines 72-74 amended by T. Armstrong, moved and seconded. Add "ISA and GA should be supervised directly by a faculty or staff member and provided evaluative feedback on a regular basis as decided by the department" Voting Results: Yes=31, No=14. Amendment **Passes**.
    - Line 98 amended by T. Armstrong, moved and seconded. Add "Students unrepresented by bargaining units wishing to appeal their termination may do so in writing to the Department Chair before the start of the subsequent term." A friendly amendment (FA) by K. Fleming to replace "department chair" with "appropriate administrator." FA was accepted by T. Armstrong. Pausing at this point due to time certain.

- 8.3 Proposed Revision of PS 08-02, Cheating and Plagiarism Policy (AS-1094-19/CEPC/FPPC)—SECOND READING TIME CERTAIN 3:00 PM
  - Motion made by N. Schurer to start at the top of this policy and move forward ad seriatim. Motion moved and seconded. Voting Results: Yes=41, No=4. Motion *Passes.*
  - Line 29 amended by N. Schurer, moved and seconded. Add language "1.2 Two groups may be involved in pursuing alleged cheating or plagiarism: the OSCED.....one of these groups."

Voting Results: Yes=38, No=4. Amendment *Passes*.

- Line 34 amended by N. Schurer, moved and seconded. Add language "1.3 The faculty member makes decisions with regards to assignments and grades (section 4.6 below), which the student may appeal independent of the review of cheating or plagiarism (section 6 below). The OSCED determines disciplinary actions with regards to the student (section 5.1.2 below)." FA by P. Shankar to add "to the department Grade Appeal Committee" on line 35. Voting Results: Yes=38, No=7. Amendment Passes.
- Line 63 amended by N. Schurer, moved and seconded. Replace "Academic" with "Initial faculty and student" Voting Results: Yes=45, No=1. Amendment **Passes**.
- Line 71 amended by A. Colburn, moved and seconded. Add "other evidence" Voting Results: Yes=42, No=1. Amendment **Passes**.
- Line 70 amended by S. Zhang, moved and seconded. Add word "video" Voting Results: Yes=31, No=14. Amendment **Passes**.
- Line 66 amended by A. Colburn, moved and seconded. Add "...the student was responsible for an..." Voting Results: Yes=42, No=43. Amendment Fails.
- Line 70 amended by A. Colburn, moved and seconded. Remove "or other physical evidence"
  - Voting Results: Yes=42, No=1. Amendment Passes.
