- 6. SPECIAL ORDERS
  - 6.1 Report from CSULB Provost Karyn Scissum Gunn TIME CERTAIN 2:10 PM KSG reports on nearing the end of the semester. The BEACH is ranked #3 by the Social mobility index for advancing social mobility in the nation. We are #2 master's level, #1 best value in the West by Washington monthly. COVID updates, last week we had very few cases reported. Student religious exemptions are steadily increasing. Currently 98% of in person students are vaccinated. When more students are in person, we expect those numbers to drop due to exemptions. 99.8% of faculty have completed the attestation process. Many represented staff categories, and those numbers vary across the categories. Chancellor Castro, who met with a medical consultant, spoke with University presidents about Omicron variant. The new variant appears to be highly transmissible. It is unclear if the current vaccines will be effective against the new variant. Vaccine modifications may be available once this variant is more widely understood. For spring 22, as related to instruction, 80% are planned FTF or hybrid, 20% online. Assuming safety levels remain as they are, the delivery mode planned must be adhered to as closely as possible.
  - 6.2 Report from CFA Co-President, Deborah Hamm- DH reports on the current continued bargaining, reminds us to keep putting on the pressure, and encourages involvement in Contract Action teams (CAT). Two parts of bargaining are occurring at the same time. Contact <u>cgarridoortega@calfac.org</u> to join a CAT team.
  - 6.3 Report from CSULB Senator to the Academic Senate of the CSU, Eileen Klink- EK presents the highlights of the September Plenary. Best budget since 1984 says Chancellor Castro. The CSU has requested nearly \$700M increase in funding. One-time funding request of \$1B for new construction put forth. AB 927: https://leginfo.legislature.ca.gov/faces/billTextClient.xhtml?bill\_id=202120220AB927\_and AB 928: https://leginfo.legislature.ca.gov/faces/billTextClient.xhtml?bill\_id=202120220AB928\_signed by the Governor. AB 927 increases possibilities for CCC to give 4-year degrees. Could lead to the reorganization

of the "Master plan for higher education". There is a need for CSU faculty participation in all stages of design and implementation. Need faculty reps for Faculty Discipline Review Groups (FDRG) and Course Identification processes (C-ID). Other news included discussions on Health and safety of faculty, staff and students. Changing modalities and on Equity Diversity and Inclusion on campuses.

Replace current wording with "an academic integrity violation", vote on amendment, yes=46 no=3, amendment passes. Line 79, section 2.0 WE for Extenuating Circumstances. JC amendment 1, moved and seconded; replace wording with "acute medical or behavioral (mental) health conditions, vote, yes=46 no=4, amendment passes. JC amendment 2, add "Each case is reviewed on a case by case...Graduate studies" moved and seconded. Vote on amendment, yes=49 no=1. amendment passes. Vote on policy as a whole. yes=47 no=2 **Policy passes**

Fall 21 launched a series of workshops aimed at enhancing the mental, physical and economic well being of faculty and staff via the Faculty Center. The charge is shown to AS with suggestions solicited. AC moves to vote on supporting this by the Senate. Moved and seconded. yes=36 no=0 . senate supports the formation of this task force. Passed unanimously.
