6.1 Report from CSULB President Jane Conoley, TIME CERTAIN 2:10 PM – JC remarks on cleaning done overnight due to COVID exposures. Last week 45 cases. There were two clusters of students. DAS has received a grant to have mental health specialists accompany police on calls. Damian Zavala was the faculty member who championed and won that grant to establish the Mobile Crisis Unit with UPD. Applied for a grant for affordable housing, did not receive that grant. Basketball team is competing in Big West championships. Two searches, Chief of police and VP Future Planning, are in final stages. VP for URD search to begin soon. Social workers will begin working with UPD in the fall. JC says affordable housing for faculty and staff may be available in the future. VP Fleming states that the modality that courses are offered in are decided by the department chair and dean, based on pedagogy. An individual can get an accommodation by going through the ADA process. CSULB may not get as much extra enrollment dollars as hoped, but it will get some. Extra enrollment dollars are those beyond our actual numbers.

6.2 Report from CFA Co-President, Deborah Hamm- DH reports that the faculty raise has not been disbursed yet. Hope it will arrive with the April paycheck. HERFF funds may arrive before the raise. Equity conference is currently happening. Some sessions being recorded and will be posted on the equity conference website. Job security for contingent faculty still being worked on by CFA as well as more ways to support working parents and alternatives to police on campus.  Colburn, no objections. Tabled at this point.

8. NEW BUSINESS

8.1 Proposal to change the name of College of Professional and International Education (CPIE) to College of Professional and Continuing Education (CPaCE) (AS-1163-22/CEPC/URC)—TIME CERTAIN, 3:05 PM Presenter: Dr. Jeet Joshee, Associate Vice President, International Programs and Global Engagement- JJ reports on the name change proposal. NH asks if we may do this proposal early; P. Soni moves this, seconded. First reading moved by P. Soni, seconded. CPIE has self-support and the International programs are stateside. The decision to split came about last year in light of the heightened focus for both areas in the Beach 2030 plan. Due to the split, name change is needed. Continuing education focuses on the professional side. This will mirror the systemwide name of PACE. International education and global engagement will be run by CIE. Faculty led study abroad during winter and summer

will be run through self-support. Administrative reorganization will have the International Education component be separate under AA. IE will not be a "college", it provides support services to students. Moves to second reading at next AS meeting.

8.2 Presentation on AB 928: Student Transfer Achievement Reform Act of 2021: Associate Degree for Transfer Intersegmental Implementation Committee—TIME CERTAIN, 3:40 PM- NH presents the Student Transfer Achievement Reform act of 2021, he informs senate about the bill and its likely impact on our campus and the CSU system. California assembly bill that changes the California education code, signed into law by Governor Newsom in October 2021. Presented as a way to remove barriers.

urged the Governor to veto this; the Governor signed this. This requires a singular lower division GE pathway used to determine eligibility to the CSU and the UC. Attempts to improve transfer efficiency for CCC students transferring to CSU or UC. This mandates that the single pathway must be established by ICAS by May 2023. Intersegmental Committee of the Academic senates (ICAS). If they do not agree by 5-31-2023, the administrators will make the decision. Deadline by fall 2025 to have this be the singular pathway for lower division get to the CSU and UC. The bill must not lengthen the time to degree or the number of units needed. Intersegmental GE Transfer Curriculum (IGETC). There are eleven courses required for IGETC for a total of 33 or 34 units. This list is organized differently from our current list. Currently 39-40 lower division units, a few of our GE requirements not included in IGETC; (oral communication, critical thinking, lifelong learning and self-development). Three courses in social science and proficiency in a foreign language are included in IGETC. Will not lose the ethnic studies course in this plan. The implementation of this bill will have a greater impact on CSU than the UC. This is because the CC and the CSU's are controlled differently by California law. The ASCSU would like feedback from faculty about what the pathway should be. We will likely have to cut six units of what we currently have for GE. Do we want oral communication, lifelong learning or critical thinking? What do we consider the most important? There is a survey asking for feedback: https://www.csulb.edu/academic-senate.
