 - i. SLOs:
 - 1. Question: Do we require Bloom taxonomy?
 - a. Comment in Chat: Need to align the course the SLOs with GELOs in terms of Bloom's taxonomy as much as possible without being tied to exact wording
 - 2. Question: Can one SLO address multiple GELOs?
 - a. Discussion ensued, consensus that for these SLOs it would be difficult to assess all the GELOs
 - b. Chat: Label with just the primary GELO that applies to each SLO instead of including multiple ones
 - ii. Assignment:
 - 1. Discussion ensued that each assignment should clearly align with GELOs
 - iii. Outline of subject matter:
 - 1. Suggestion that more details or information be added to show alignment of GELOs with subject matter.

 - 1. Needs to add one co/prerequisite from the Foundation courses
 - 2. Does the course allow for personal self-reflection not seeing enough in justification so we understand how they work together. SEND to Exec with SCOs for other two E courses.
 - 3. SLO 1 Could they cut the "engage in the process of lifelong learning in healthrelated topics" clause and start with "acquire...."
 - 4. How is SLO 2 demonstrating reflecting on lifelong behaviors conducive to selfdevelopment/GELO 1? – NO, but it is something addressed in other courses
 - 5. Is SLO 6 really addressing personal behaviors/GELO 4?
 - 6. Want greater articulation in weekly topics that shows connection to GELOs
 - 7. F/S unanimously approved

 - ii. <u>Motion</u>: Ask for more connection between GELOs and Asssessment and reviewed by executive committee F/S unanimously approved
