



Seiji Steimetz is Professor and Chair of Economics at the California State University, Long Beach. He also serves on the Executive Committee of the METRANS Transportation Center – a joint research center of Cal State Long Beach and the University of Southern California. By balancing the interests of the residents, as well as businesses, the DLBA creates tangible progress by way of vested interest and solidified partnerships across local, municipal, and commercial lines. Also, under Kojian's leadership, the Long Beach Downtown Development Corporation, a 510(c)3 entity was formed to provide economic resources to underserved corridors citywide.
