Research Interests

Professor High's teaching and research focus on the "Age of Schiller" as well as literary, philosophical, and theoretical texts from the eighteenth to the twenty-first century. His seminars – "Friedrich Schiller," "The 'German' Novella from Boccaccio to Stephen King," "Heinrich von Kleist," and "Thomas Mann und Franz Kafka, Erzählprosa," and "International Short Story" – teach interdisciplinary approaches to the intersections of literature, philosophy, critical theory, and politics in German, European, and US culture. Professor High has received numerous awards for teaching, service, and scholarship, and currently teaches as a Visiting Professor at the German Summer School of the Pacific.
