- Jeff Klaus, AVP Student Engagement, Student Affairs
 - Recent campaign: "Speak Boldly & Listen Bravely"; supports students to understand the Time, Place and Manner (TPM) policy
 - TPM impacts all of us here on campus
 - Why is this an issue now? The CSU system recently came up with a TPM policy document affecting all campuses. It was legislatively mandated by the Budget Act of 2024; we have a systemwide policy and each campus had an addendum on this policy document.
 - We had 2 weeks to come up with our campus addendum after the CSU document was released. We've always had regulations for meetings, protests, posting, etc, so I sent it to the CSU. Some faculty and staff expressed concern

because they thought it was a new policy, but it had actually always been there. It seems new because it is now part of the bigger CSU document.

- There is flexibility to review and change certain parts of this-- so please let us know if you have any concerns.
 - Something new: In our public spaces (QUAD, Speakers' Platform, by the Outpost..), between 12-2pm, you can have sound amplification without needing advance permission.
- If you have any pain points related to the TPM policies, please let us know so we can review them and have conversations to make changes to support what we want. Please reach out to Jeff.

- Speak Boldly & Listen Bravely
 - a training program to train staff and student leaders for learning about student rights and policies
 - a cross-discipline committee helped us put together the content
 - This committee helps us to understand how to balance student rights and be prepared for new situations on campus
- Dr. Kevin Johnson: our rationale for this committee:
 - We've had Time, Place, Manner regs for some time. We also have the right to be safe and secure, have due process of law, etc., so sometimes these rights have to be negotiated because they come in conflict with each other.
 - The university's role is to protect everyone's rights; but we also have to protect the learning environment from disruption. How do you define "the learning environment"? That's where we are challenged and where our policies come into play to help us keep all these rights balanced so that one doesn't infringe on another. So, our regulations are written to protect people and not to berate anyone. We are constantly revising and reviewing our regulations to refine and adapt to new situations.
