V. Ongoing Business/Updates

A. Discussion about CCC Charge

Two weeks ago, the Academic Senate (AS) had the first reading of the revised charge; the second reading will take place tomorrow. We will have a time certain at 2PM and it will be a hybrid meeting. We are all welcome to attend. As of now, Pei-Fang has received no recommendations, so we expect to have no changes to make.

Shae and Mitra did a great job representing the committee; Shae gave a detailed summary about the reasons why we needed to update the charge.

Related topics:

The Beach 2030 Campus Climate Survey is being distributed; this group could engage in supporting that effort. This is the only entity that is officially charged with campus climate. The Beach 2030 organizers should send a representative and learn about the work we do. We are currently preparing for the next survey.

We are going through the THRT process and are working through the toolkit, so we know how to engage in the next assessment process. They should support our leadership and assessment efforts.

Another important topic is GE, specifically the California transfer curriculum. We are going to have a unified GE pathway going forwards. If we have two sets of GE patterns, that can create confusion. Many faculty across the system are upset about this.

VI. New Business

A. TRHT Toolkit – Decision Fatigue Activities

Discussion about the THRT framework:

The Campus Climate Committee is the local coalition where a lot of the vision, planning, and implementation regarding campus climate happens. In alignment with Beach 2030, THRT is trying to address exclusion, discrimination, inequality, and structural barriers to opportunities. The language of Beach 2030 matches the THRT framework.
